

**MINUTES FOR THE 10th ANNUAL MEETING**  
**OF THE**  
**VG&RC COMMUNITY ASSOCIATION, INC.**  
**MARCH 27, 2018**  
**AT THE VENETIAN RIVER CLUB**  
**VENICE, FLORIDA**

1. Call to Order: John Moeckel, President, called the meeting to order at 5:30pm on March 27, 2018 and welcomed everyone to our 11<sup>th</sup> annual meeting. Diane Maskol confirmed that a quorum of the membership was present through attendance or proxy. Proof of notice of the meeting was established via email and on the Association's website. John Moeckel gave the President's report and spoke of this being the Association's 11<sup>th</sup> year and was formed to get Venetian residents involved in issues outside the community.

Bill Dwyer, Membership chair, was absent so John Moeckel gave his report. Our membership is now at 895, which is an increase of 150 since last year.

4. Other reports: Jerry Jasper, external affairs committee chair, reviewed the issues that this committee and the board have been addressing over the past year:

- City of Venice comprehensive plan
- Bridges development
- John Nolen apartment project
- Concrete crushing operations – Crush It and McLeod Crushing
- Sarasota Memorial Hospital at their Laurel Road site
- Dona Bay water storage project
- Laurel Road expansion to 4 lanes

John Moeckel took a few questions from the floor at the end of the meeting.
